1.4 ACTION SUBMITTALS

- A. Product Data: For each type of product.
 - 1. Include construction details, materials descriptions and tested physical properties of materials.
 - 2. Include manufacturer's instructions for evaluating, preparing and treating substrate.

- B. Shop Drawings:
 - 1. Show locations and extent of application.
- C. Samples:
 - 1. For each product specified, two samples, minimum 4 inches square, representing actual product color, sheen and texture.

1.5 QUALITY ASSURANCE

- A. Qualifications:
 - 1. Manufacturer Qualifications: Company with minimum 15 years of experience in manufacturing of specified products and systems.
 - 2. Applicator Qualifications: Company with minimum of 5 years' experience in application of stains and finishes as specified in this section on projects of similar size and scope, and employs installers and supervisors who are trained by and acceptable to product manufacturer.
 - a. Successful completion of a minimum of 5 projects of similar size and complexity to specified Work.
- B. Field Mock-up:
 - 1. Install at Project site or pre-selected area of building an area for field mock-up, as directed by Architect.
 - 2. Apply material in strict accordance with manufacturer's written application instructions.
 - 3. Manufacturer's representative or designated representative will review technical aspects; surface preparation, application, and workmanship.
 - 4. Field sample will be standard for judging workmanship on remainder of Project.
 - 5. Maintain field mock-up during construction for workmanship comparison.
 - 6. Do not alter, move, or destroy field mock-up until Work is completed and approved by Architect.
 - 7. Obtain Architect's written approval of field mock-up before start of material application, including approval of aesthetics, color, texture, and appearance.
 - 8. Subject to compliance with requirements, field mock-up may become part of the completed Work, if undamaged at time of Substantial Completion.

1.6 DELIVERY, STORAGE, AND HANDLING

- A. Comply with manufacturer's ordering instructions and lead-time requirements to avoid construction delays.
- B. Deliver materials in manufacturer's original, unopened, undamaged containers with identification labels intact.
- C. Transport and store in unopened containers and keep in clean, dry condition protected from rain, dew, and humidity.
- D. Do not allow Water-Base ZAR[®] or NuDeck[®] to freeze.

- N. Exterior Stained Wood Doors.

 - a. ZAR[®] Exterior Water-Base Poly High Performance [Gloss] [Semi-Gloss] [Satin] [Matte].
 - b. ZAR[®] Exterior Oil-Base Poly Ultraviolet [Gloss] [Satin] [Matte].
- O. Exterior Fiberglass Doors.
 - 1. Embossed Wood Grain Finish:

- a. 1st Coat: ZAR[®] Interior Oil-Based Wood Stain.
- b. 2nd Coat: ZAR[®] Interior Oil Based Wood Stain (if desired).
- c. Apply Three protective topcoats of either the following products:
 - 1) ZAR[®] Exterior Water-Base Poly High Performance [Gloss] [Semi-Gloss] [Satin] [Matte].
 - 2) ZAR[®] Exterior Oil-Base Poly Ultraviolet [Gloss] [Satin] [Matte].
- 2. Water-Base Acrylic Translucent Aliphatic Urethane Exterior Multi-Substrate Siding Finish.

 - 1) ZAR[®] Exterior Water-Base Poly High Performance [Gloss] [Semi-Gloss] [Satin] [Matte].
 - 2) ZAR[®] Exterior Oil-Base Poly Ultraviolet [Gloss] [Satin] [Matte].
 - 2. Water-Base Acrylic Translucent Aliphatic Urethane Exterior Multi-Substrate Siding Finish.
 - a. One Coat: ZAR[®] Platinum PRO Translucent Exterior Urethane Finish.
 - b. 2^{nd} Coat if desired.
